Ships Cook – EU citizens

*) Certificate of competency as ships cook – issued in EU/EEA

*) Medical certificate for seafarers and fishermen	

Ships Cook – Non EU citizens

*) 48/24 – declaration. Declaration confirming that the ship's cook has had an apprenticeship of at least 48 months, of which at least 24 months has been on a seagoing vessel. The declaration should be on official paper, stamped, and signed by the shipping company. ⁴	
*) Certificate of Proficiency basic safety and fire-fighting on ships, completed or refreshed within the last 5 years (STCW reg. VI/1 – 1-4)	
*) Copy of Passport	
*) Medical certificate for seafarers and fishermen	

¹ Mandatory if the applicant is going to serve as an officer on a tanker. Copies of course certificates will not be accepted.

² Enclose copy of diploma if the applicant has a certificate of competency issued in the Philippines.

³ Enclose documentary proof of assessment or statement of competency if the applicant has a certificate of competency issued in the Philippines (only if the assessment is not performed at SYNERGY in Manila).

⁴ Certificate of competency as ships cook issued of the authorities of the Philippines and documentation for a minimum of 5 months Sea Service as a Ship's Cook.
