This form must be used when applying for registration of an EU-, EØS (EEA) jointly owned shipping company. It must also be used when a jointly owned shipping company elects a new managing shipowner or a new manager. The form must be accompanied by a copy of the passport or identity document.

If the ship is registered in the Register of Shipping, the Danish International Register of Shipping, the Shipbuilding Register or the Boat Register, proof of ownership of the ship or the share in the ship must be enclosed. Normally, such proof will be in the form of a bill of sale.

If the ship is not registered in the Register of Shipping, the Danish International Register of Shipping, the Shipbuilding Register or the Boat Register, the application for registration of the ship must also be submitted.

If a joint owner is a company that is not registered in the Register of Shipping, the company must be registered at the same time and documentation of proof of nationality must be included by a copy of the Register of Companies.

For attesting witnesses who are citizens of an EU-, EØS (EEA) country but not Danish citizens then a copy of the passport or national identity card is required.
