This form must be used when applying for registration of an EU-, EØS (EEA) company without limited liability.

The form must be accompanied by a copy of the national identity card or passport for natural persons.

If the ship is registered in the Register of Shipping, the Danish International Register of Shipping, the Shipbuilding Register or the Boat Register, proof that the company is the Shipowner must be enclosed. Normally, such proof will be in the form of a bill of sale.

If the ship is not registered in the Register of Shipping, the Danish International Register of Shipping, the Shipbuilding Register or the Boat Register, the application for registration of the ship must also be submitted.

If the company is recorded in a foreign register, a transcript from this register must be enclosed. The section liable participant does not need to be filled in if this transcript is enclosed. If the company is not registered in a foreign register, the company's contract or articles of association (translated into Danish or English) must be enclosed.

If one of the liable participants is a company that is not registered in the Register of Shipping, the company must be registered at the same time.
