Order repealing a number of orders, technical regulations, etc. in the maritime field

Section 1. On 15 April 2012, the following orders, technical regulations, etc. shall be repealed:

- 1) Order no. 175 of 21 May 1965 on the carriage of easily sliding cargoes by ships.
- 2) Order no. 81 of 14 March 1969 on ships' supplies with drinking water in Danish ports.
- 3) Order no. 195 of 12 May 1970 on the carriage by sea of hazardous, liquid chemicals in bulk.
- 4) Guidance no. 1004 of 14 September 1973 on permanently inflated rubber boats in certain ships below 500 GRT.
- 5) Guidance no. 10002 of 8 May 1974 on the construction of lifeboat davits and winches.
- 6) Circular no. 10011 of 25 August 1981 concerning approved permanently inflated rubber boats.
- 7) Order no. 525 of 30 October 1981 on the safety and health conditions on training ships, etc.
- 8) Order no. 10002, technical regulation of 30 September 1983 on the carriage by sea of dangerous goods.
